The Central Philippines State University, through the General Appropriation Act (GAA) intends to apply the sum of FORTY NINE MILLION PESOS ONLY (49,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of 3 - Storey (27 Classroom) School Building / 18-02-2019BID. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Central Philippines State University, now invites bids for the Construction of 3 - Storey (27 Classroom) School Building and works is required 280 working days except Sundays and holidays. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is open to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
