Purchase of Agri-machineries

The Central Philippines State University, through the Internally Generated Income 2018 intends to apply the sum of ONE MILLION ONE HUNDRED FIFTY FOUR THOUSAND PESOS ONLY being the Approved Budget for the Contract (ABC) to payments under the contract for Purchase of Agri-machineries. Bids received in excess of the ABC shall be automatically rejected during bid opening.

The Central Philippines State University now invites bids for Purchase of Agri-machineries. Delivery of the Goods is required to deliver on 60 days after signing the contract. Bidders should have completed, within 60 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from Central Philippines State University and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be acquired by interested Bidders on Wednesday, April 04, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of 5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.


