## Purchase of investigative equipment

The Central Philippines State University, through the Internally Generated Income 2018 intends to apply the sum of THREE MILLION ONE HUNDRED FIFTY TWO THOUSAND SEVEN HUNDRED THIRTY PESOS ONLY being the Approved Budget for the Contract (ABC) to payments under the contract for Purchase of investigative equipment. Bids received in excess of the ABC shall be automatically rejected during bid opening.

The Central Philippines State University now invites bids for Purchase of investigative equipment. Delivery of the Goods is required to deliver on 60 days after signing the contract. Bidders should have completed, within 60 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from Central Philippines State University and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be acquired by interested Bidders on Wednesday, April 04, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of 5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Central Philippines State University will hold a Pre-Bid Conference on Wednesday, April 11, 2018 at exactly 10:00 am at Board Room, ALC Building, CPSU, Kabankalan City, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before 10:00 AM of Tuesday, April 24, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on April 24, 2018 at exactly 10:00 am at Board Room, ALC Building, CPSU, Kabankalan City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Central Philippines State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
